RE: Technical Review of Planned Ground Run-up Enclosure (GRE) at Billy Bishop Toronto City Airport – Results and Next Steps

Thank you for your letter dated August 23, 2016. PortsToronto confirms that we are agreeable to the Matters to be Addressed in the Consent Agreement, as included in Appendix A, and that we will respond to the Summary of Agency and Stakeholder Questions and Comments, as summarized in Appendix B in a timely manner.

We have begun working with our technical experts and staff to reply to the various agency and stakeholder questions and comments raised throughout the City's review process. We anticipate having responses ready for distribution over the next few weeks and well in advance of the start of above-grade construction.

I would like to take this opportunity to thank the City of Toronto for facilitating the constructive community consultation meeting on June 28, 2016 with regard to the planned Ground Run-up Enclosure at Billy Bishop Toronto City Airport. As the operator of an airport located near the city's thriving mixed-use waterfront, PortsToronto works very hard to be responsive to our neighbouring community. In addition to a number of noise mitigation measures already in effect at Billy Bishop Airport, the new proposed Ground Run-up Enclosure will take our efforts one significant step further by dramatically dampening the acoustic impact from engine run-ups.
