1. Welcome and Land Acknowledgement

Geoffrey Mosher (LURA) welcomed members of the Billy Bishop Toronto City Airport (abbreviated to the Airport subsequently) Community Liaison Committee (CLC) to the 57th committee meeting.

2. Review of Meeting Minutes & Action Items

Mr. Mosher provided an overview of the agenda. The meeting agenda is included in **Appendix A**. Mr. Mosher also noted that the 56th CLC minutes were distributed to the CLC membership for comment and review. The minutes will be published on the PortsToronto website once finalized.

Deborah Wilson (PortsToronto) then presented a land acknowledgment.

After that, Mr. Mosher reviewed the CLC's Terms of Reference (TOR) and encouraged everyone to contact him if they desired a copy.

Key points from Mr. Mosher's review of the TOR are as follows:

- PortsToronto established the CLC in 2010 as a non-statutory forum for dialogue with Airport stakeholders to share information and receive feedback on downtown Toronto's Airport operations and growth plans.
- The CLC operates as an advisory body to the Airport senior management team, providing an opportunity to ask questions, seek clarity, and work in the spirit of collaboration to provide constructive comments and suggestions on the Airport's activities which implement its Master Plan's directions including:
 - Airport operations and plans that may affect the health, safety, community, and economic conditions in the surrounding area;
 - Noise management; and;
 - City building and environmental sustainability initiatives.
- The CLC is not a venue focused on the following:
 - PortsToronto's operations affiliated with the Port of Toronto, Cruise Ship Terminal, or Outer Harbour Marina;
 - Making decisions about the current or future operations of the Airport;
 - Reopening the directions established through the Master Plan (the Master Plan is a separate and distinct process for establishing the direction of the Airport).
 - Airing individual member concerns that are not reflective of their broader constituencies.
- This CLC is comprised of members who are generally representative of the waterfront community, including people representing the interests of waterfront residents, businesses, consumers, the traveling public, and aviation industry representatives.
- Membership is guided by eligibility criteria and the process described in the TOR. CLC members are guided by these terms and participate in the CLC at the Airport's discretion.
- Members must declare a conflict of interest before becoming a member of the CLC and/or before addressing specific matters where an actual or perceived conflict of interest may exist.
- Mr. Mosher, as the facilitator, is here to lead the meetings and endeavors to the following:
 - o Identify the purpose, objectives, and opportunities for input into agenda items at each meeting to

ensure they meet the intended mandate of the CLC TOR;

- Keep meeting items timely within the allocated time set in the agenda;
- Ensure that the roles and responsibilities are upheld;
- Seek to ensure that a plurality of voices and opinions are heard throughout;
 - Mr. Mosher will actively call upon individuals to ask if they have questions or comments on an item and keep the discussion moving along to welcome broad participation.
- Ensure productive discussion;
- Remind participants of previous conversations and topics beyond the scope of the committee's mandate, to avoid repetitive discussions; and
- o Document a complete and accurate record of the CLC meetings.

Mr. Mosher presented the outstanding action items, which are as follows:

- M#56-A1 PortsToronto will consider creating a report capturing the number and types of flights outside operational hours.
 - This item was addressed in the CLC 57 presentation and is considered closed.
- **M#56-A2** Joan Prowse (BQNA) will explore alternative and additional communication methods that the Airport could adopt.
 - This item is ongoing.
- **M#56-A3** PortsToronto will consider contacting the Winward Co-op to inform them of the Airport's Sunflower Program with Hal from YQNA assistance to find the contact.
 - This item is ongoing.

Mr. Mosher asked the members if there were any questions about the agenda items.

BQNA representative Joan Prowse inquired about securing a date and time for a tour of the Airport's storage facilities and other new activities. Mr. Mosher noted that this action may have been unintentionally missed through the transition between CLC facilitators. Securing a tour date and time will be added as an action item.

M#57-A1 - LURA and PortsToronto will schedule a tour of the Airport's storage facilities and other new activities.

3. Airport Business Updates

Warren Askew (PortsToronto) presented the Airport Business Updates. PortsToronto's updates were accompanied by presentation slides, which are included in **Appendix B.** Key points from Mr. Askew's presentation are summarized as follows:

- Passenger data for January 2025 reflects flat passenger traffic compared to January 2024. This is on par with January 2023.
- Aircraft movements reflect a 23% increase from January 2024 to January 2025. This is on par with January 2023.
- Dash 8 movements are down 3% in January 2025 compared to January 2024. Overall, Q400 (Dash 8-400) movements have remained consistent from 2023 to 2025.
- Helicopter movements are up 157% in January 2025. The Airport is investigating these unusual movements.

- For after-hours flights, only medevac flights are permitted, however are minimal from September to January. Non-commercial flights are permitted during restricted times. Fixed-wing medivac movements are low.
 - BQNA representative Joan Prowse inquired about the difference between the left and right helicopter movement graphs.
 - Mr. Askew responded that the left graph compares helicopter movements versus medivac movements, as the right graph reflects after-hour medivac movements.
- There was a significant increase in noise complaints during the fourth quarter (Q4). The Q4 noise reports are in the process of being finalized.
- Approximately 250 complaints were issued last year, many being aircraft-related. 45% of aircraft-related complaints result from helicopters and 34% result from commercial flights. General aviation and medivac flight complaints are minimal, while military aircrafts have no complaints.
- Noise complaints were mostly located at York Quay Neighbourhood and Bathurst Quay Neighbourhood last year.
- From the analysis, four individual residences accounted for 82% of the total complaints.

After the update, Ms. Prowse (BQNA) inquired if the complaints were analyzed per individual or building. Mr. Askew clarified that complaints are logged and analyzed per individual residence/unit, not per building. Ms. Prowse (BQNA) suggested that if one individual is issuing 47% of complaints, finding out what the issues are and who they are from can be beneficial.

Mr. Askew noted that many Q4 noise complaints were of a lower quality, meaning they are not actionable and/or have missing key information, such as incident dates/times and specific aircraft details, making it challenging to follow up. Ms. Prowse (BQNA) noted that the recent website changes may have caused a lack of this key information, as the old noise complaints form no longer exists on the website.

Mr. Mosher provided a link to the new complaints form on the Airport's website:

YQNA representative Hal Beck requested examples of non-actionable and incomplete complaints. Mr. Askew confirms that a summary of common complaints, categorized by theme, will be provided at the next CLC meeting.

City of Toronto representative Jay Paleja suggested that access issues to the Airport's complaints form should be on the agenda for the next Noise Management Sub-Committee meeting. Mr. Mosher confirmed that this action will be added to the NMSC meeting agenda.

M#57-A3 - LURA will add an item to the NMSC meeting agenda to discuss access issues related to the Airport's complaints form.

Toronto Island Yacht Club representative Bill Duron thanked PortsToronto for taking noise complaints seriously. Mr. Duron (Toronto Island Yacht Club) inquired if the volume of complaints received from waterfront residences has encouraged improvements from PortsToronto. Mr. Askew noted that despite changes in Q4, overall operations have remained stable. General aviation continues to make up a large portion of total traffic, this is not proportionately reflected in the number of complaints. He suggested that the rise in complaints may be more attributed to increased public awareness during Q4 than to any substantial operational shifts. Mr. Beck (YQNA) agreed that complaints tend to spike when the Airport is more prominent in public discussion.

Mr. Askew reassured the group that PortsToronto follows up with NavCanada about general aviation complaints

and actively follows up on non-compliant aircraft operations. He noted that PortsToronto is committed to fair and consistent enforcement regardless of aircraft operator. Mr. Duron (Toronto Island Yacht Club) acknowledged that the trendline of complaints suggests they have been well-managed. Mr. Beck (YQNA) added that he has seen significant improvements made by the Airport and noted that a number of ongoing issues are still pending resolution.

University of Toronto Municipal Affairs representative Mark Maloney inquired about if the helicopter data presented reflects only Airport-related helicopters, or if it includes helicopters operating outside the Airport. Mr. Askew clarified that there are two reports: Airport-operated helicopter movements and general noise complaints. PortsToronto is responsible for capturing and responding to all noise in the vicinity of the Airport, therefore, the complaints that come through are not always related to the Airport. For instance, private helicopters to the East of the Airport are also reflected in the noise complaints. Mr. Maloney requested that a separate noise complaint report be provided, differentiating between Airport-related complaints and non-Airport-related complaints. Mr. Askew confirmed that this can be further investigated.

4. Groundside Operations

Mr. Mosher invited Chris Pearce (PortsToronto) to provide an update on the Groundside Operations. Mr. Pearce invited two guests from the City of Toronto (Zahid Hassan and Stephanie Gris Bringa) as well as two guests from the Toronto Transit Commission (Kristjan Naelapea and Michael Vieira) to present an update on the work at Bathurst Street and Lakeshore Boulevard.

Key points from their presentation are as follows:

- Phase 1 of construction has started, as Phase 2 is approaching.
- Construction will involve watermain and TTC track replacements.
- The contractor has removed TTC tracks and will begin the water installation.
- There is a slight work delay due to a pending relocation from Enbridge Gas. Completion is now expected before the end of May rather than end of June.
- Starting Monday, March 3rd, there will be a road closure on the southbound lane for watermain work and TTC track renewal.
- A rerouted replacement bus (509B Harbourfront) will be issued to accommodate the closure.
- The 511 Bathurst Streetcar diversion will remain unchanged.
- Airport access to the westbound service will remain unchanged. The temporary stop at Queens Quay and Bathurst will remain.
- Eastbound service will be located at Dan Leckie and Queens Quay. A rerouted replacement bus will be issued to travel via Housey St. and Dan Leckie Way to avoid the southbound lane closure.

Following the presentation, BQNA representative Joan Prowse asked whether someone traveling to Queens Quay would need to go to Dan Leckie and where the transit stop would be located. Mr. Naelapea clarified that passengers transferring from a streetcar should disembark within the loop at Queens Quay and then board the replacement bus at the westbound stop on the northeast corner of Spadina and Queens Quay to continue toward Exhibition. Ms. Prowse (BQNA) expressed concern about potential confusion regarding the transit stop location and suggested improved signage. Mr. Vieira agreed that better signage is essential for clear navigation.

Mr. Beck (YQNA) expressed concern about the full road closure and requested further clarification. Mr. Hassan

clarified that the closure would start on March 3rd and continue until the end of April. There will be a southbound lane closure for the water main installation and TTC track work, and the northbound lane will remain open. Mr. Beck (YQNA) highlighted other work that is compounding the area's traffic issues. Mr. Vieira explains that traffic impacts are being considered, paid duty officers (PDOs) and customer service representatives will be deployed to assist with vehicular traffic and transfer passengers, and contractors will be instructed to keep traffic flowing.

Mr. Pearce thanked the speakers for their updates and shared that an updated construction notice will be available on the website at Project Webpage: <u>toronto.ca/BathurstLakeShore</u>. 5. Airport Operations

Mr. Pearce (PortsToronto) provided an update on Airport Operations:

- Winter operations to remove snow, due to the high volume produced from the recent storm, are currently ongoing
- Annual wildlife certificates have been renewed for 2025.
- Collaboration with the Toronto Region Conservation Authority (TRCA) to manage wildlife on Muggs Island is ongoing.
- Continued support for the Noise Management Subcommittee initiatives is ongoing.
- Crossing limitations have been implemented on the runway to reduce congestion. Only essential, oversized, and emergency vehicles are allowed to divert.

After the presentation, BQNA Representative Joan Prowse inquired whether only emergency vehicles and trucks could use the ferry. Mr. Pearce confirmed that regular use is also permitted. Ms. Prowse asked for clarification on the duration of the crossing limitations. Mr. Pearce clarified that the limitations will remain until construction is completed - in May.

6. Community Outreach Update

Mr. Mosher invited Ryan White (Nieuport) and Jessica Pellerin (PortsToronto) to present updates on Community Outreach Update. This is summarized as follows:

- The following programs help celebrate the tunnel's 10th anniversary:
 - **Public Art Program:** A prospective public art program took place in January 2025, drawing much interest from the community. Twenty panels have been installed for the program, enabling the Airport to feature art throughout the year. There will be a six-month rotation of art. The first rotation will consist of three artists: Que Rock, Jonathan Gazze, and Mariana Hernandez.
 - Artist Open Call: The Airport website will host an open call for artists to submit their work for consideration. The deadline is May 1st, 2025. The Airport will cover production, installation, and artist fees. The submission details are on the Airport website. The second exhibition is expected to go live in the summer of 2025.

- BQNA representative Joan Prowse asks for confirmation that the submission deadline is May 1st and whether the art must be professionally produced.
 - Ms. Pellerin confirmed that the Airport would cover the artist's costs and provide an honorarium. More information is available here: <u>Perspectives - Billy Bishop</u> <u>Toronto City Airport</u>
- **The Sunflower Program:** This program supports people with hidden disabilities, is currently operating at the Airport. People can now request a Sunflower lanyard for discreet assistance.
- **The Ambassador Program**: This program is currently operating at the Airport. This volunteer-based passenger assistance initiative currently has two volunteers and plans to expand.
- StreetARToronto Mural Installation: In the Summer of 2025, the Airport will feature an art mural installation developed in partnership with the StreetARToronto, Jacaranda Graphic Collective, and the Waterfront Neighbourhood Centre on a large wall outside the Airport terminal facing the waterfront. The idea is to represent the community and people who live, work, play, and study on the waterfront while reminding all that the Airport sits on Indigenous lands and water. The team is seeking public input on the mural through workshops hosted in February 2025.

After the presentation, City of Toronto representative Jay Paleja requested an update on the electric buses. Mr. White responded that Nieuport is currently working to source electric buses and will provide a progress update once more information is received.

M#57-A5 - Nieuport will provide a progress update once more information is available regarding the electric buses.

7. Capital Program Update

Mr. Mosher invite Jelena Ognjavonic and Bojan Drakul to present the Capital Program Update. This is summarized as follows:

- The following three projects are currently ongoing:
 - **Mainland Ferry Slip Corners Rehabilitation:** The project is almost complete, pending significant fixes. Final work will be completed as the weather improves.
 - **Airport Electrical Infrastructure Improvements:** Work is scheduled from February to October 2025. There will be short power outages requiring generators during equipment transition.
 - **USCBP Preclearance Facility:** This is progressing as scheduled. Completion is targeted for late 2025.
- The following nine projects are scheduled for construction this year:
 - Ferry Ramps Hydraulic Upgrades. Following structural repairs, this is scheduled from March to July 2025 to upgrade the hydraulic system. There will be some nighttime work required but less noise than previous repairs.
 - **Mainland Passenger Terminal Facility (PTF) Roof Replacement:** This is scheduled from May to June 2025 due to the current roof nearing the end of its lifespan. Work will be done during the daytime for safety without significantly impacting operation.
 - CBSA CCTV Base Building Expansion: This is scheduled from March to April 2025 to add cameras required for the CSBA area. This will enhance security at BTTCA. There will be work daytime and nighttime with no disruption to the public.

- West Service Road Rehabilitation: This is scheduled from April/May to July/August 2025 to rehabilitate the road, adjacent parking, and underground service. The project will include the rehabilitation of the island turning circle as well. There will be a minor phase approach to minimize disruption, with some nighttime work.
- **Mainland Island Passenger Terminal Facilities Renovation**: This work is to renovate the terminal interior and add retail space. This is scheduled to be completed in Q2-Q4 2025. Work will take place during the daytime and nighttime.
- **New Flag Poles:** This is scheduled to be completed in the Summer of 2025 during the daytime. The location is still to be finalized.
- **Ferry Entrance Gates:** This work is scheduled from April to June 2025, to have a new automated ferry entrance gate on the mainland for security. Work obstructing the ferry will be done at night, and all other activities will be done during the day.
- Island East Wall Rehabilitation: Work is scheduled from April to October 2025. This new wall is required for significant demolition and will include raising the crest to protect from high water. Most work will be done during the day, with some night work required.
- **New Equipment Storage Structure**: Work is scheduled from May to December 2025, to make a new equipment storage on the Airport's south side. This work will be during the day.
- Ports is committed to providing adequate notice of all the projects and minimizing the impact of any construction on the community.

After the presentation, YQNA representative Hal Beck thanked the Airport team for keeping noise levels down and minimizing nighttime construction. Mr. Beck (YQNA) requested clarification on the age of the mainland terminal roof. Ms. Ognjanovic clarified that the roof is 30 years old. Mr. Beck (YQNA) asked where the new flag would be located. Mr. Drakul and Ms. Ognjanovic shared that the new flag would be located somewhere at Maanjidowin, near the ferry, however the design has not yet been finalized. Ms. Wilson shared that there will be three flag poles, with the last one having the Mississauga of the Credit First Nation Flag.

City of Toronto representative Jay Paleja asked about paving work south of the Airport runway. Mr. Drakul answered that no paving work was done last year. There was a road improvement into the park around the southside pavement that was fixed.

8. CLC Member Updates

Mr. Mosher invited CLC members representing organizations to provide any updates. The updates are summarized as follows:

- BQNA Representative Joan Prowse shared that the Air Quality Team met with Angela Homewood (PortsToronto) and Jay Paleja (City of Toronto) to discuss how to share information and recommendations for the Air Quality Study. The next team meeting is still being scheduled.
- Ms. Prowse shared an update on the encampments. Only two tents remain, with housing being arranged expected at the end of February. Security will remain for one additional month to prevent further encampments. The committee is forming a plan for a family-friendly vision of the park. The supervised injection site inside the shelter will close at the end of March, which will reduce drug-related issues.
- Mr. Prowse shared that she is stepping down as the BQNA chair. Bev Thorpe will be the new chair, while Ms. Prowse will remain the chair at the Air Quality Subcommittee, Toronto Emergency Measures Committee as well as continue to attend CLC meetings if Ms. Thrope cannot.

9. Business Arising

After sharing updates, University of Toronto Municipal Affairs representative Mark Maloney asked if the impact of

the U.S. tariff on the Airport (passenger movements, budget implications, Nieuport and Porter Airline impacts, etc.) could be discussed at the next meeting. Mr. Mosher noted that if any updates on impacts are available, they can be shared at the next CLC.

M#57-A6 - PortsToronto will discuss the implications of the U.S. tariffs on the Airport.






Passenger Traffic





Aircraft Movements



Dash 8-400 Movements


